SMALL THINGS, BIG IMPACT

Did you know that 52% of 6 to 9-year-olds in Oregon have a cavity, 20% have untreated decay, and 14% have rampant decay?

Dental issues can keep kids out of school and cause financial and emotional stress for families struggling to get by. Plus, more serious health problems can result later in life from poor oral care. Providing dental health kits to young children is a simple way to help eliminate the dental health crisis facing our children.

This year, we partnered with Burley to assemble and distribute 30,000 dental kits to children ages 3-10 across Lane County. Kits included a toothbrush, toothpaste, floss, and resources for parents. Teachers received curriculum support about why it's important to take care of your teeth.

POSITIVE STARTS FOR KIDS



Investing in early education is the most cost-effective way to close the opportunity gap and improve long-term outcomes for children. However, the cost of childcare in Oregon rivals that of in-state college tuition. Many families, particularly those identified as ALICE (Asset Limited, Income Constrained and Employed), are just above the eligibility cutoff for child care assistance, but also cannot afford high-quality care for their children.

With funding from the Early Learning
Division of the Oregon Department of
Education, Preschool Promise is a model
for a publicly-funded, high-quality preschool
system. In Lane County, Preschool Promise
provides 175 opportunities for eligible
three to five year olds at 130 high-quality
participating preschools at no cost to
their families. From culturally responsive
environments and inclusive programming
to well-educated teachers working to
engage parents, the program builds a
comprehensive learning environment to
create lasting benefits.

THE VALUE OF VOLUNTEERISM

Volunteering continues to play an important role in our work by engaging the community through connecting people to opportunities that make a difference in a tangible way.

Overall, United Way of Lane County engaged 2,286 volunteers in 57,752 hours of service valued at \$1,394,133. Here are some higlights of volunteer engagment over the past year:

General Volunteerism

- 1,652 volunteers gave 4487 hours
- Over 100 individual and/or group volunteers were connected to opportunities throughout Lane County, and 57 agencies received 373 referrals through our volunteer website

Day of Caring

- 44 participating companies assisted 43 nonprofits in6 cities served. In total 959 volunteers gave 3,387 hours.
- > Total monetary value of \$81,762!

RSVP (retired & senior volunteers)

- > 451 volunteers served 7,430+ individuals
- 765 individual meals delivered through Meals on Wheel and 665 individuals served a meal at Café 60 sites

Impact (Education, Financial Stability, Health)

- > 101 volunteers gave 426 hours
- 73 volunteers gave 342 hours to serve 659 children at Summer Reading Spots

Day of Action (Kindergarten Readiness Kits)

101 volunteers gave ovet 200 hours to assembled 900 kits

Resource Development

- > 78 Volunteers gave 657 hours
- 35 Volunteers served the workplace campaign as advocates



30 YEARS OF SERVICE

This year, 2017, RSVP of Lane County celebrates a milestone—30 years of volunteer service. Volunteers have given over one million hours of service to our neighbors in need. United Way of Lane County has been Lane County's program sponsor in January 2003.

INCREASING ENGAGEMENT



One of the ways we bring people together is through our affinity groups, Emerging Leaders and Retire United.

Emerging Leaders is a collaboration of young professionals and future community leaders with the goal of creating a positive local impact through philanthropy, leadership development, volunteering, networking and community awareness. We believe these leaders are our future, so we have made it a priority to help grow this group, and it shows.

Because we also recognize the value of our seasoned philanthropists and community leaders, we have launched a new affinity group this year, Retire United. This group provides a way for retirees to continue to stay engaged with each other and the work of United Way.

BIG CONVERSATIONS

In October we held the 4th Annual Legislative Breakfast to bring together non-profit leaders and state legislators to discuss current issues and share what is happening with legislation that may impact the work in our community.

The discussion focused on three topics: housing and homelessness, issues surrounding access to quality healthcare, and equity (how to create opportunities for those with the least access).

We're grateful to everyone who participated, especially our panel speakers Sen. Lee Beyer, Sen. James I. Manning, Jr., Rep. Nancy Nathanson, Rep. Julie Fahey, and Rep. John Lively.


