EDUCATIONAL ACCESS FOR KIDS MOST IN NEED:

PRESCHOOL PROMISE



We know a child's chances of succeeding in school are largely determined before they even set foot in a kindergarten classroom. But stresses – financial pressures, geographic isolation, racial discrimination – can prevent families from accessing early learning support.

With funds from the Early Learning Division of the Oregon Department of Education,

Preschool Promise provides 190 slots for eligible 3-5 year olds at qualified preschools across Lane County. This means 190 families who struggle to make ends meet receive free, high-quality, culturally

responsive and inclusive preschool for their

THE VALUE OF VOLUNTEERISM



In 2017-18 overall, United Way of Lane County engaged **1,793** volunteers in **39,205** hours of service valued at **\$967,971** to Lane County.

Our young professionals group, **Emerging Leaders**, had significant growth and exciting monthly programs this year, including hearing from local leaders about the state of our region, discussing why 3rd grade reading levels matter, learning the art of negotiations, and conducting a very successful book drive. We also launched a new group, **Retire United**, to keep retirees engaged in our community.


